Instructions for Filling out a Public Information Request Form

1. Media Selection: CD-ROM or Paper
2. Optional Extracts: An option may be selected to select a limited group of voters. Suspense voters are those voters whose certificate was returned as non-deliverable from the Post Office.
3. The attached affidavit must be signed before a deputy election official OR a notary public. CD-ROM will not be released until full payment is received. A complete address must be provided along with a telephone number. The Waller County Election Official will furnish information no later than the 15th day after the date the request is received. (Texas Election Code, Section 18.066)

§ 18.067 Unlawful Use of Master File Information

(a) A person commits an offense if the person uses information in connection with advertising or promoting commercial products or services that the person knows was obtained under Section 18.066.

(b) An offense under this section is a Class A misdemeanor.
